Below are the high-level consequences of failing an audit. The largest impact is that it can put your Federal Contactor dollars and future awards at risk.

Financial:

- Can negatively affect the ability to win any future contract awards
- If discrimination is found in hiring practices and/or compensation; fines can go up to \$1M+

Non-Financial:

- Conciliation Agreement: Incorporates the resolution of the pattern or practice violation and any other violations included in the Notice and can include monthly check-ins or progress reports.
- Negative Publicity: All Conciliation Agreements are public record


